- Celebrate the 75th Aniversary of the Word Family Organization.

## Expected Results

- Outline possible new collaboration models between Local Governments and Family Organizations to provide partnership schemes addressing the implementation of the Neew Urban Agenda and SDGs 1, 2, 3, 4, 5, 8, 10 and 11 .
- Draft and approve co nclusions and recommendations of the World Family Summit 2022 Declaration to be sent to the 2022 UN ECOSOC HIGH LEVEL POLITICAL FORUM.



## TO THE WORLD FAMILY ORGANIZATION HONORARY MEMBER – MR. MARCEL VAN BREEN

### PORTRAIT By Geert Van Hecke

At the age of ninety-seven, Marcel Van Breen can call himself the proud great-great-grandfather of Emile, his great-great-grandchild who was born last summer. This ancestor of an extensive progeny speaks with pride about the many 'grand-men' he has already seen growing up: "They are doing a great job, let them do."

The life of Mr Van Breen, as many have known him in the past at the Gezinsbond Organization cannot be summarized in one stroke of the pen. His mother was widowed at a young age and Marcel - officially called 'August' - seemed destined to continue working on the farm at home. But the pastor and the head teacher, he says, persuaded my mother to let me go to normal school. Then I joined the 'White Fathers', until after six years I was judged as 'not called'."



### Who is Marcel Van Breen?

- Born on December 31, 1925 in Oostmalle.
- He was the third in a family of eight children. He was twelve years old when his father died and his mother has to run the farm alone.
- Studies to become a teacher thanks to, among other, the Study Fund and Widows and Orphans Fund of the Gezinsbond.
- Entered the Missionaries of Africa (better known as the “White Fathers”), but the superiors judge that he is “not called”.
- Trained from 1950 at the Center for Anti-Aircraft Artillery (Lombardsijde) as a reserve officer of the Belgian army.
- Joined the Social Services of the army and the gendarmerie in Sijsele near Bruges in 1964 as a captain-commander (retirement at 51 years old).
- Graduated in 1963 with the first group of students of Family Sciences (now co-university college Odissee in Schaarbeek); wrote his dissertation on children’s rights and UNICEF.
- Holden various positions as a volunteer at the Gezinsbond; has been chairman of the Flemish Housing Fund for 25 years and Vice President for Legal Affairs of the World Family Organisation for 36 years.
- Returns from Bruges in 2015 with his wife Jeanne (deceased in 2019) to a residential care center in his native region of Malle, where many family members also live.
- Is the proud Grand-Men of eleven grandchildren, twelve great-grandchildren and one great-great-grandchild.

The World Family Organization, in the occasion of the celebrations of its 75th Anniversary, is proud and honored to pay tribute to Mr. Marcel Van Breen for the long years devoted to the organization and for his wise advise to those who came after him, till the present days.

**Guest of Honor | Mr. Nikhil Seth**  
United Nations Assistant Secretary-General,  
Executive Director, UNITAR



On 8 June 2015, Mr. Nikhil Seth was appointed by the United Nations Secretary-General Ban Ki-moon as UN Assistant Secretary-General, Executive Director of the United Nations Institute for Training and Research.

Before assuming the post of the UNITAR Executive Director, Nikhil Seth was the Director of the Division for Sustainable Development, Department of Economic and Social Affairs (DESA) at the United Nations Secretariat in New York. In this role he served as head of the Rio+20 secretariat and of the secretariat for the Third International Conference on Small Island Developing States, spearheading the preparations for these conferences in Rio, Brazil, and Apia, Samoa. He was also closely engaged in coordinating and advancing their follow-up.

Mr. Seth's Division was also responsible for supporting the intergovernmental negotiations for the post-2015 development agenda, which was adopted at the United Nations Sustainable Development Summit 2015 in September 2015.

During his career with the United Nations since 1993, Mr. Seth has served as Special Assistant and Chief of Office to the Under-Secretary-General for Economic and Social Affairs (Sept 1993 – Jun 2001), Chief of the Policy Coordination Branch in the Division for ECOSOC Support and Coordination (Jun 2001 – Jan 2003), as Secretary of the Economic and Social Council (ECOSOC) and the Second Committee of the General Assembly (Feb 2003 – Aug 2006), and as Director of the DESA Office for ECOSOC Support and Coordination (Aug 2006 – Aug 2011), where he guided the ECOSOC's work in implementing several new key mandates, including its Annual Ministerial Review and Development Cooperation Forum.

Before joining the UN Secretariat, he was a delegate to the UN in the Permanent Mission of India to the United Nations (Sep 1990 – Sep 1993) and involved with various UN conferences and summits including the Rio Summit on Environment and Development and the climate change related process. After joining the UN, he has been involved in the organization of the Copenhagen Summit on Social Development, the Monterrey Conference on Financing for Development, the Mauritius Conference on Small Island Developing States, the Millennium Summit, World Summit on Sustainable Development and the UN World Summit, beside the Rio+20 Conference.

He joined the Indian diplomatic service in 1980 and his diplomatic assignments included Geneva, Democratic Republic of Congo, Central African Republic, Gabon and Equatorial Guinea.

Before joining the Indian diplomatic service, he worked as a Lecturer in Economics in St. Stephen College, Delhi University for 2 years (Aug 1977 – Sep 1979).

Mr. Nikhil Seth holds a Masters degree in Economics from Delhi University.

Local councils have, for example worked with Mutual Aid groups to coordinate food and medicine deliveries, set up ‘listening crews’ to reach out to the lonely and isolated, and develop their own systems of record-keeping and safeguarding.

But even prior to the pandemic, councils taking on a more preventative approach to public services were already starting to adopt a more facilitative role, building community capacity by fostering a wider ecosystem of support and activity. Several councils have been exploring asset-based approaches that focus on what people can achieve for themselves, rather than what services can do on their behalf. In practice, this new approach can lead to a more relational model which emphasises building meaningful relationships with communities and developing networks of reciprocal exchange and support.

One of the key principles in building community capacity is co-production, which is critical in fostering shared understanding and ownership within the community. Simply defined, co-production is a meeting of minds coming together to find a shared solution. It involves delivering public services in an equal and reciprocal way between professionals, service users, their families and neighbours.

On this occasion of World Family Summit but also the commemoration of the 75 anniversary of WFO, I would like to thank Dr. Deisi Kusztra – President of World Family Organization for her determination and great leadership and the hard work to support the Families issues all over the world.

I look forward to a successful World Family Summit and I’m sure the coming out resolution with concrete proposals will be a reference for the future role of all families in development, because our goal is “Invest in Families to not Left any Family Behind”.

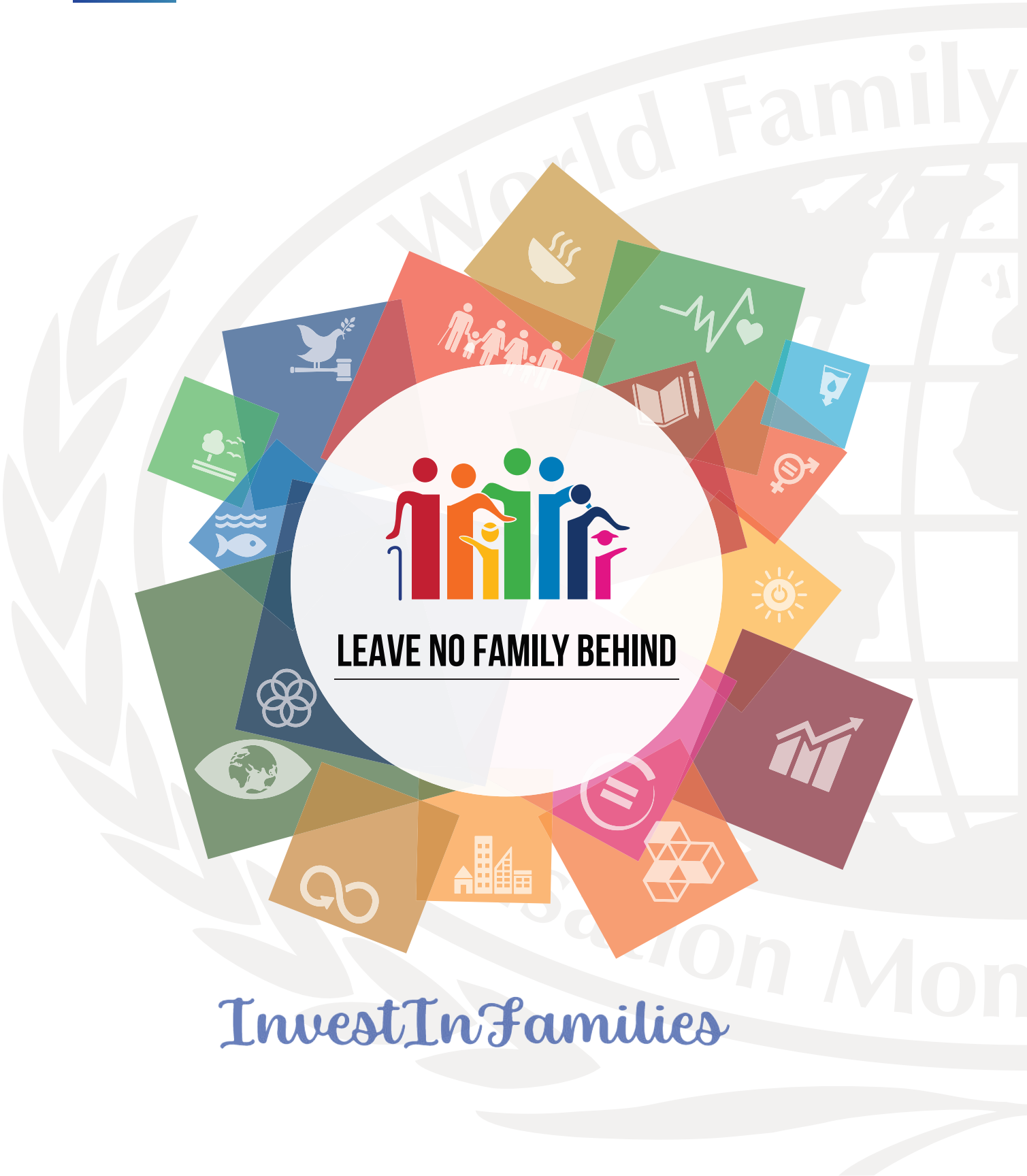

Seventen years ago, the EMMCA was founded in L’Hospitalet as a new model of music school that uses music as a tool for inclusion and social change. The ONSTAGE Transfer network follows the Good Practices, which has an innovative methodology engaging civic society. Making a difference from traditional music schools, the project gives equal opportunities to all inhabitants of L’Hospitalet to access music courses, involves primary schools and creates a space for social cohesion, tackling local issues such as exclusion, youth unemployment and school dropout.

Success Story II

Housing a better future for Roma in Cluj-Napoca

Presenter: Alexandrina Kiss - Cluj Metropolitan Area Inter-community Organization – Romania

The project aims to reduce the housing, social and economic disparities between the disadvantaged community of Pata Rât and the majority population of Cluj-Napoca and to tackle the risk of social exclusion among other poor families in the Metropolitan Area of Cluj, especially Roma families, but not only, which, in the absence of the support offered by the project, could be constrained to move to Pata Rât or other marginalized areas.

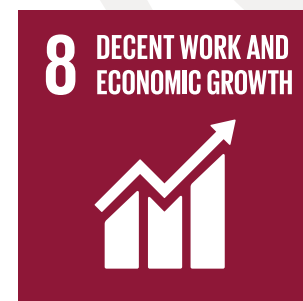

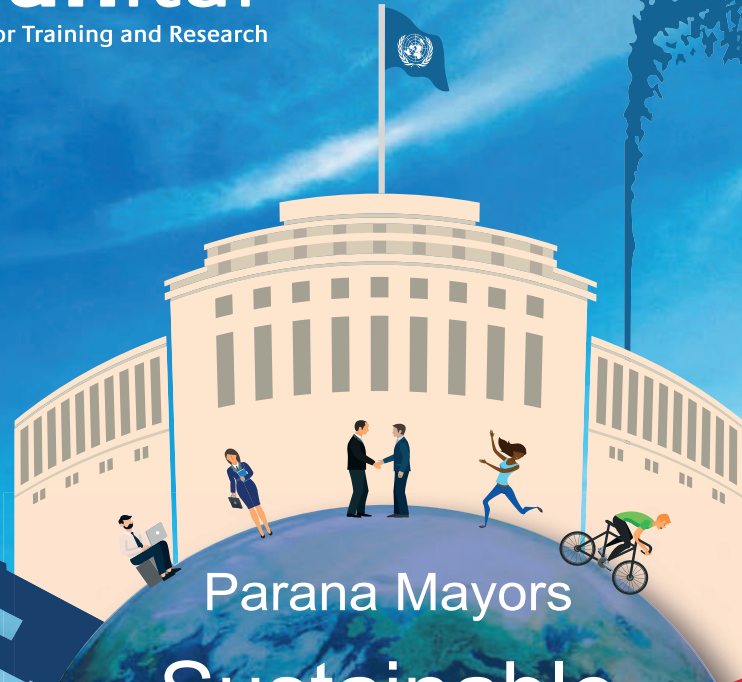

## Guest of Honor

### Carlos Massa Ratinho Junior - Governor of Paraná State Brazil

Carlos Roberto Massa Ratinho Junior is the second youngest governor in the history of Paraná and began his political leadership trajectory very early. At the age of 21, he was elected House Legislator. In 2006, he ran for federal deputy and was elected second highest in votes for the Chamber. He was re-elected four years later with the largest vote in the history of Paraná at the time, totaling 360,000 votes.

In the National Congress he was elected leader, being the youngest leader in the history of his party. Back in the Legislative House of Paraná, in 2014, Ratinho Junior won his second term as state deputy with more than 300,000 votes, being the candidate elected with the highest number of votes in Brazil proportionally. He was State Secretary for Urban Development, 960 projects were completed with R\$1.7 billion invested in agreements that served 392 cities.

Graduated in Marketing and Advertising (International Faculty of Curitiba), he has a postgraduate degree in State Law at the Pontifical Catholic University of Brasília and a specialization course in Tax Administration and Tax Reform and Society, at the Complutense University, in Madrid (Spain). Elected in 2018, in the first round, with 3,210,712 votes.





## Alex Mejía

### Division for People and Social Inclusion

Mr. Mejía was appointed Director of UNITAR's Division for People and Social Inclusion in 2018. Within the Division, he also serves as Senior Manager of UNITAR's Social Development Programme (SDP), which he has led since October 2012. Prior to these posts in Geneva, Mr. Mejía served for three years as Director of UNITAR's Hiroshima Office in Japan, and for four years as Director of UNITAR's CIFAL training centre in Atlanta, USA. In his current capacity, he serves as Director of UNITAR's global network of 21 training centers, and is also responsible for several other programmes within UNITAR's Division for People and Social Inclusion, including the Nigeria Project Office and the Human Mobility Programme managed out of New York.

Mr. Mejía is a citizen of Ecuador, and his career spans two decades in private and public organizations. After obtaining his first master's degree in 1992, he worked in corporate banking in Latin America for six years. In 1998, he joined his country's foreign service as a diplomat, serving as Counsellor at the Ecuadorian Embassy in Bogotá, Colombia. In 2001, he became Vice Minister of Economy for the Republic of Ecuador. During this period, he also served as Alternate Governor to the International Monetary Fund, to the World Bank, and to the Inter-American Development Bank, and as a member of the Board of Directors of Ecuador's Central Bank. From 2003 to 2005, he worked in Washington, DC as the Director of the

Inter-American Council's Andean Program, an entity chartered by the Organization of American States.

Mr. Mejía holds a master's degree in Foreign Affairs from Georgetown University in Washington DC, and a master's degree in Business Administration from INCAE University in Costa Rica. He also holds a Diploma in Political Leadership from Harvard University.
