The World Family Summit +7 was hosted by the World Family Organization, in partner-ship with the General Women's Union of UAE, UN DESA ECOSOC Office for Support and Coordination, the UN DESA NGO Branch and the UN NGO Inter-Regional Network (NGO-IRENE) in Abu Dhabi, United Arab Emirates from 5 to 7 December 2011.

Encompassing with the theme of the 2012 UN ECOSOC Annual Ministerial Review, "Promoting productive capacity, employment and decent work to eradicate poverty in the context of inclusive, sustainable and equitable economic growth at all levels for achieving the Millennium Development Goals", the theme for our World Family Summit +7 is: Families in Balance: Working our way towards Sustainable Development - Making Decent Work and Social Protection a Global Reality for All Family Members.

The global economic and financial crisis has had wide-ranging impacts on families all over the world, and has resulted in a significant increase in the number of families vulnerable to poverty. The World Family Summit +7 committed to introduce a Family perspective to the achievement of MDG 1, which includes the implementation of the Decent Work Agenda, the Global Jobs Pact and Universal Social Protection, discussed these initiatives and presented ideas and new commitments which were registered in the World Family Summit +7 Abu Dhabi Declaration on MDG 1.

Statement

Abu Dhabi Declaration — World Family Summit +7

We, ministers and representatives of Government, civil society organizations, non-governmental organizations, academia, parliamentarians, the private sector, media and families, 352 participants from 76 countries representing all continents of the world, participating in the World Family Summit +7, having fulfilled the Summit agenda with fruitful plenary discussions,

Having considered the theme to be discussed at the high-level segment of the Economic and Social Council in 2012 and the annual ministerial review ("Promoting productive capacity, employment and decent work to eradicate poverty in the context of inclusive, sustainable and equitable economic growth at all levels for achieving the Millennium Development Goals"),

Noting that in the Universal Declaration of Human Rights and the International Covenant on Economic, Social and Cultural Rights include the notion of the right to decent work and social protection,

Acknowledging the impact of the international financial and economic crisis on social protection, job creation, food prices and on the capacity of the international community to meet the poverty and hunger targets set out in Goal 1 of the Millennium Development Goals,

Noting that the provision of decent work and social protection schemes is essential for families to lift themselves out of poverty and for the achievement of the Goal 1 of the Millennium Development Goals,

Supporting the International Labour Organization (ILO) Decent Work Agenda through the implementation of the four strategic objectives of ILO — creating jobs, guaranteeing rights at work, extending social protection and promoting social dialogue, with gender equality as a cross-cutting objective, and recognizing that these objectives are inseparable, interrelated and mutually supportive,

Reaffirming the ILO Declaration on Social Justice for a Fair Globalization, adopted by the International Labour Conference at its ninety-seventh session, in 2008, which reflects the wide consensus on the need for a strong social response to globalization in achieving improved and fair outcomes for all, and constitutes a compass for the promotion of a fair globalization based on decent work,

Recalling the unanimous adoption of "Recovering from the crisis: A Global Jobs Pact" by the International Labour Conference at its ninety-eighth session, in 2009, which promotes a productive recovery from the international financial and economic crisis centred on investments, employment and social protection,

Supporting the resolutions and conclusions adopted by the International Labour Conference at its 100th session, in 2011, in particular the efforts to make decent work a reality for domestic workers worldwide and the recurrent discussion on social protection (social security).

Emphasizing that effective national social security systems are powerful tools to provide income security, to prevent and reduce poverty and inequality, to promote social inclusion and dignity for all families, as they enhance access to health care,

provide income security, facilitate access to education and reduce child labour and in particular eliminate its worst forms,

We unanimously resolve to commit ourselves:

- (a) To advocate that full and productive employment and decent work opportunities for all family members be put at the heart of crisis responses, and for the elimination of discrimination based on gender, age, ethnicity or disability;
- (b) To advocate for a Green Economy regulatory framework for the creation of decent and green objectives, which supports sustainable development, thereby reducing social gaps;
- (c) To support the inclusion of the family perspective in the United Nations Conference on Sustainable Development "Rio+20", to be held in 2012;
- (d) To affirm that international labour standards, as set out in the Decent Work Agenda, create a basis for and support rights at the work place, thereby contributing to the building of a culture of social dialogue, which is particularly useful in times of crisis. It is important to recognize that respect for fundamental principles and rights at the workplace is essential for human dignity, recovery and development, in order to prevent a downward spiral in labour conditions and ensure that families are provided with decent work opportunities;
- (e) To call on all Governments, the private sector, civil society, community leaders and families to work together in order to prevent, reduce and eliminate all forms of forced labour, in particular the worst forms of child labour;
- (f) To urge all stakeholders to create decent work opportunities for youth, including the provision of vocational and technical training and entrepreneurial skills development, especially for unemployed youth, to ensure the well-being of the next generation of families;
- (g) To call on all Governments and employers to ensure that decent work opportunities are equally available to women and men, and to integrate gender concerns in all financial and economic crisis recovery measures;
- (h) To welcome the adoption of the Domestic Workers' Convention, 2011, and Recommendations, and urge all stakeholders to implement it, inter alia, by recognizing the importance and urgency of ensuring decent working conditions for domestic workers worldwide, the majority of whom are women, which will benefit them and their families;
- (i) To raise awareness among Governments, at both the national and local levels, of the contribution of small and medium-sized enterprises and microenterprises to decent work opportunities for families, and promote measures, including access to affordable credit and green financing that would ensure a favourable environment for the sustainable development of families;
- (j) To celebrate the International Year of Cooperatives in 2012, in recognition that cooperatives contribute to improving the well-being of families via poverty reduction, employment generation and social integration at the local community level;
- (k) To advocate for sustainable social protection systems, as appropriate, that assist vulnerable families, prevent extreme poverty, address social disparities, help

to stabilize the economy, and maintain and promote job opportunities and that they be included as an integral part of crisis response measures;

- (I) To urge Governments and all stakeholders to protect families by strengthening social protection systems and provide them with adequate social protection throughout all stages of the life cycle, in both urban and rural areas to meet the specific needs of vulnerable groups and children, including indigenous people, minorities, migrant workers and their families, people with disabilities, people living with HIV/AIDS and people under occupation and in armed conflicts;
- (m) To urge Governments and all stakeholders, when strengthening social protection systems, to take into account the changing roles of women and men with respect to work/family balance, employment and family care responsibilities, promote gender equality and empowerment and provide maternity protection, ultimately benefiting families;
- (n) To call upon all development partners to support developing countries to achieve family stability by promoting priorities such as education, maternal health, gender equality and addressing public goods, including long-term scientific capacities, environmental management, regional integration and cross-border infrastructure;
- (o) To call on Governments and all stakeholders to recognize that peace and mediation begins in the family and to develop the necessary legislation that supports families in the eradication of domestic and gender-based violence, highlighting the role of mediation in dispute and conflict resolution, preventing human suffering and creating conditions conducive to lasting peace and sustainable development.

The Organization welcomes all families of the world to join it in efforts with the United Nations, Governments and all stakeholders to fulfil their commitments towards achieving the Millennium Development Goals and constituting the biggest partnership with a view to building a present and future world characterized by more peace, security, justice, equity, transparency, tolerance, solidarity, prosperity and integration, by mobilizing and promoting the basic economic, political, sociocultural and sustainable unit of society — the family.
